**Issue of RFID Tags for Authorized 4 Wheeler(s) & 2 Wheeler(s)**

Friends,

RFID Tags for authorized 4 wheeler(s) and 2 wheeler(s) to be issued and displayed for authorized vehicles to enter / exit Camellia Apartments will commence from today (15.03.2023)

**Schedule of distribution of RFID Tags as mentioned below**

A Building	9 <sup>th</sup> April to 15 <sup>th</sup> April (excluding 14 <sup>th</sup> April)
B Building	1 <sup>st</sup> April to 8 <sup>th</sup> April (excluding 7 <sup>th</sup> April)
C & D Building	15 <sup>th</sup> March to 22 <sup>nd</sup> March (excluding 17 <sup>th</sup> March )

Apartment Owners / Tenants, to visit the Manager's Office between **10am to 5pm** to collect their respective RFID Tags.

Upon Verification of documents by the Manager, pertaining to additional parking Owned or Rented, additional RFID Tags will be provided by paying a sum of ₹ 50/- each for Four Wheeler(s) and ₹ 50/- each for Two Wheeler(s). **Payment accepted only in the form of Cash. No other form of Payment will be accepted. Please tender exact change.**

Four Wheeler(s) / Two Wheeler(s) have to be in the name of either of one of the members residing within Camellia Apartments to enable us to provide a Tag. This is applicable for additional Four Wheeler(s) and Two Wheeler(s) as well. **This is a mandatory requirement.**

The issued RFID Tag(s) are the sole responsibility of the owner and any damage to the Tag(s) will have to be reported to the Manager immediately.

A Copy of the Proof of Ownership has to be provided while collecting the RFID Tag(s).  
All members to abide by traffic rules and be mindful not to damage the Electronic Boom Barrier System,

Remember to Slow Down at gate and wait for the barrier to open completely  
Please dip the headlamps at night to enable security guards to see you clearly  
Please Do Not honk inside the Apartment Complex  
Kindly stick to the Speed Limit of 20km/Hr. within the complex

**From 01<sup>st</sup> May 2023 onwards 4 Wheelers and 2 Wheelers without tags will not be allowed to park inside Camellia Apartments.**
